An Overview of Gun Laws in the United States

Gun owners, dealers, and collectors must follow state and federal laws if they wish possess a firearm, or run a business selling guns. The [Second Amendment](#) of the U.S. Constitution says that "the right of the people to keep and bear Arms, shall not be infringed." Gun owners often cite the Second Amendment when arguing against state or local gun law restrictions.

Infringe: When you infringe upon someone's right, you do not let him do something he believes he has the legal right to do

Federal Gun Laws

Federal law restricts who can own, possess, or sell a gun. The [National Firearms Act](#) makes it illegal for a person to have a firearm that is not specifically registered to them. While President, Bill Clinton passed the Brady Act to that gave even more specific guidelines for who can and who cannot own a gun. Under the [Brady Act](#), you cannot have a gun for personal or business if you:

1. Were convicted of a crime punishable by being in prison for more than one year;
2. Are a fugitive from justice;
3. Are addicted to, or illegally use, any controlled substance;
4. Have been ruled mentally defective by a court, or are committed to a mental institution;
5. Are an illegal [citizen] living in the United States unlawfully;
6. Received a dishonorable discharge from the U.S. Armed Forces;
7. Renounced your U.S. citizenship, if you are a U.S. citizen;
8. Have a court restraining order that prevents you from seeing or communicating with your 'intimate partner,' your partner's child, or children; or
9. Were convicted of domestic violence in any court of a misdemeanor.

(1) The “Defense” of Marriage is a Defense of Valueless Tradition

The “Defense” of Marriage is a Defense of Valueless Tradition

No one should be denied the opportunity to choose his or her husband or wife. Choosing who to spend your life with is a basic human right and deeply personal (decision). In our past, the government has denied people the right to marry one another in order to make them feel less than human or “wrong”. For example, once, two slaves could not get married, nor could an interracial couple. Many families that our society readily accepts and embraces today were once not able to legally marry. These families included interracial couples like Mildred and Richard Loving. Even though they were a man and a woman hoping to get married, they could not in their home state of Virginia because Mildred was black and Richard was white. The couple took the case to the supreme court and were finally allowed to marry in 1967. The Supreme Court declared (antimiscegenation) laws illegal in (Loving v. Virginia), which proves that we should not just accept whatever the law defines as marriage. While not everyone in our community wishes to marry, everyone deserves the freedom to make this choice.

(2) Federal Rights and Protections Granted to Married Couples

There are 1,138 benefits, rights and protections provided to married couples. Since the Defense of Marriage Act defines "marriage" as a legal union between one man and one woman, same sex couples cannot receive any of these benefits. Therefore, even if same-sex couples are considered married by the state they live in, they are not allowed to receive benefits from the government. These benefits include Social Security after a spouse has passed away. All working Americans give money to Social Security through the taxes they pay. Once they have retired, they receive the money back in monthly payments. If you are married, when your spouse dies, you can still receive his/her Social Security benefits. However, same-sex couples cannot receive this same benefit because they are not considered “married.” Professors of economics at Columbia agree that this discrimination allows gives straight couples more economic opportunities at an older age and possibly can lead to a longer life span. This discrimination then interferes with each American’s right to life, as promised by our (Constitution).

When Will America Wake Up to Gun Violence?

Last night's shooting rampage at a movie theater in Aurora, Colorado, was a nightmare. Twelve people have been killed, with many more injured. According to law enforcement officials, the weapons were purchased legally by the suspect in the last six months.

Even when legislation passed during the Clinton years in the form of the Brady bill, requiring background checks at the time of gun purchases, or the assault weapons ban, the NRA succeeded in injecting gaping loopholes into the laws. Who needs to go through a background check at Walmart when you can get your gun without one at the local gun show or from some shady figure on a street corner? The NRA then asks how "gun control" doesn't work. But it can.

Consider what happened in Australia after a crazed gunman killed 35 people in Port Arthur, Tasmania, in 1996. The Australian federal government persuaded all states and territories to implement tough new gun control laws. Under the National Firearms Agreement (NFA), firearms legislation was tightened throughout the country. National registration of guns was imposed and it became illegal to hold certain long guns that might be used in mass shootings. The gun ban was backed up by a mandatory buy-back program that substantially reduced gun possession in Australia. The effect was that both gun suicides and homicides (as well as total suicides and homicides) fell. Importantly, while there were 13 mass shootings in Australia during the period of 1979--96, there have been none in the sixteen years since. In 1996, then-Prime Minister John Howard stated that the "whole scheme is designed to reduce the number of guns in the community and make Australia a safer place to live." The Australian attorney general praised the cooperation and responsibility of Australian firearms owners with the gun controls and buy-back, saying, "they have been paid cash for their firearms - giving our nation a welcome Christmas gift by removing unnecessary high-powered firearms from the community. It offers all of us the real chance of a safer festive season and New Year."

Just because Americans are uninsured doesn't mean they can't receive health care. Nonprofits and government-run hospitals provide services to those who don't have insurance, and according to Hospital contracts, it is illegal to refuse emergency medical service to any individual who comes to an emergency room. While uninsured Americans are a problem because they cost the system money, it is a lie to say they do not have health care. This issue shouldn't be as emotional since there are plenty of government and private medical practices designed to help the uninsured. People who seek the services of auto mechanics want car repair, not "auto care." Similarly, most people who seek the services of medical doctors want body repair, not "health care." We own our cars, are responsible for the cost of maintaining them, and decide what needs fixing based partly on balancing the seriousness of the problem against the cost of fixing it. The idea of a Universal health-care system rests on the idea that, although we own our bodies, the community or state [should] be responsible for paying the cost of repairing them.

But what is health care? Healthcare is receiving a service for a medical problem. The concept of Universal health-care service rests on the idea that if an individual has a medical problem, it received by accident or bad luck. For example, leukemia, lupus, and brain cancer are unwanted happenings that the patient cannot control. What about injuries people bring upon themselves through reckless and careless actions? Are we going to count obesity, smoking, a head injury because of drunk driving as the same kinds of diseases? Many Americans would willingly pay for insurance to protect themselves against the extremely high cost of treating their own diseases. But how many Americans would willingly pay for insurance to protect them from the expenses of treating someone else's depression?

The idea that every life is infinitely precious and therefore everyone deserves the same kind of medical care is a fine religious sentiment and moral ideal. As political and economic policy, it is [unrealistic and foolish]. The first requirement for better health care for all is not equal health care for everyone but educational and economic advancement for everyone.
